Road Safety in Brook Lane, Park Gate


Road safety at the roundabout junction of Brook Lane, Headland Drive, and Lockswood Road has been a local concern for some time and is an issue that we raised in our Spring Focus Newsletter earlier this year, and which we will discuss further in our Summer Focus Newsletter. In light of resident feedback both before and after our Spring Newsletter, we have been looking at the options open to us all to raise the profile of this issue further and to press the local authorities to take action.

The first step was to gather some hard evidence in terms of the number of children, adults, and traffic crossing this roundabout at peak times, and we completed a Traffic Survey last month.



With one of us each side of Brook Lane at the roundabout we counted the traffic going up and down Brook Lane and the pedestrians crossing Brook Lane at the roundabout from 07:30 to 09:00 on Monday 15th and 14:30 to 16:00 on Wednesday 17th. In both cases there was an hour (07:45 to 08:45 and 14:30 to 15:30) when over 1,000 vehicles went up and down Brook Lane while over 100 pedestrians had to cross Brook Lane at the roundabout.

It is clear to us that traffic calming measures need to be put in place in this part of Brook Lane to reduce the potential for accidents and to reduce the severity of any accidents that do take place.

The key to successful traffic calming is acceptance by the local community and we are looking for feedback on what you think should be done, along with your experiences of using this stretch of road.

Traffic calming measures could include such as:

- Speed humps
- Speed cushions
- Speed table
- Rumble strips
- Increased signage
- Road markings
- Signs activated by traffic to warn of excessive speed
- Speed restrictions (20 mph)
- Speed cameras
- Narrowings and chicanes kerb extensions
- Changes in road texture

Are there any other options that you can think of?



Speed humps have a short rounded top with the ramps either side painted with white arrows to make them obvious to motor vehicle drivers. The aim of the speed hump is to slow traffic to a safe speed as the ramps are uncomfortable for vehicle drivers if driven over too fast.



A **speed cushion** is a form of speed hump that allows larger vehicles, especially emergency vehicles, to straddle them without slowing down while reducing passenger car speeds. They are often installed in high-traffic areas where vehicles have a higher chance of collision with pedestrians or other vehicles.

Speed tables are a raised section of road with a ramp on both sides painted with white arrows to make them more obvious to motor vehicle drivers. Again, the aim is to slow motor vehicle traffic to a safe speed, as the ramps are uncomfortable, and can lead to vehicle damage, if driven over too fast.

Rumble strips cause audible and/or tactile feedback to the driver to warn that a junction or other danger is ahead. The driver will hear the noise the tyres make on the lines and feel feedback through the steering wheel and the suspension.





Increased Signage can highlight to motorists the potential dangers they are facing on the road ahead.

To Be Accurate the Road is Absolutely Fine...

The Solution is I Think...

As you can see traffic calming measures have been put in place in Yew Tree Drive in Whiteley, in the ward our Tory County Councillor Sean Woodward represents on Fareham Borough Council.

Traffic calming reduces the potential for accidents and reduces the severity of accidents that do take place. It appears that he doesn't want to protect Park Gate pedestrians in this way. In a recent social media discussion Sean Woodward stated "actually to be accurate the road (Brook Lane) is absolutely fine. It is that some idiots choose to drive too fast on

it." When previously asked for his solution to the problem of pedestrian safety on Brook Lane his response was "the solution is I think to take the very greatest of care when crossing Brook Lane". No mention of traffic calming to reduce the speed of those who drive too fast!

As for the two Tory Fareham Borough Councillors for the Park Gate Ward (which includes Brook Lane), they are conspicuous by their silence and absence of any input on this issue. It is clear as far as we can see that we will not get any changes to Brook Lane through the local Conservatives who seem to have no desire whatsoever to represent the views of local residents on this issue.

There are issues with other parts of Brook Lane with pedestrian safety at the roundabout junction with Bridge Road a concern, safety outside and on the approach to Brookfield School needs to be improved, and there is the desirability of a pedestrian controlled crossing to allow easier pedestrian access to the Community Hospital, Brook Lane Surgery, and the Royal Mail Delivery Office.

However, we are starting with seeking to improve the safety of pedestrians, who are predominantly school children, crossing Brook Lane at this roundabout.



Botley Road in Park Gate has a Pelican Crossing, why not Brook Lane?

According to Sean Woodward, Brook Lane is too narrow to warrant a Pelican Crossing, but as Botley Road, at the point where this crossing has been installed, is clearly narrower than Brook Lane is where the Community Hospital and Brook Lane Surgery are sited, we cannot understand his reasoning.

Action Required Please - Your Views and Experiences

We need your feedback along with your experiences of using this stretch of Brook Lane before we can move to the next stage of our campaign to press the local authorities to take action. The more 'real life' examples we can gather, the stronger the case for action becomes. Are you aware of traffic calming measures elsewhere that highlights the lack of any safety measures along Brook Lane?

What traffic calming measures would you like to see on Brook Lane? What are your experiences of using this stretch of road, and how does it compare with elsewhere.
